# How to Submit

## Palermo Occasional Papers

### Islamic History, Doctrines and Sources (PaOP)

*Palermo Occasional Papers – Islamic History, Doctrines and Sources (PaOP)* is a multidisciplinary and international journal that plans to contribute to scientific research on Islamic history, doctrines, hermeneutics, literatures, languages, relations, institutions, perception and cultures. It includes essays, articles and reviews from the classical age to the modern and contemporary one, with particular consideration for sources and philological-historical study. The aim of PaOP is to become part of the research debate in the field of Islamic studies in their broad and ever-increasing aspects, to disseminate scientific results and encourage exchange and interaction among academics of various disciplines. With its international editorial board and a standard selection process (double-blind peer review), the journal welcomes unpublished papers and invites submissions from researchers in all Islamic traditions working on Oriental languages and manuscripts. In addition to first-hand research articles, PaOP also accepts notes, documents and book reviews. It is published mainly in English.

Manuscripts should be submitted to the Editorial Board via the email address ([panzeca@fscire.it](mailto:panzeca@fscire.it)) in .doc or .docx, and pdf format by **31 May 2025**.

Books for review and submissions for exchange should be sent to:

The editorship has an international scientific and editorial board and follows the double-blind peer review procedure. The articles will be sent for reading to two referees for an anonymous evaluation. The reasoned judgment of the referees will be communicated (anonymously as well) to the authors. The evaluation of the papers will be based on the following criteria: relevance of the topics discussed and coherence with the interests of the journal, originality, clarity of exposition, treatment of existing literature, methodological carefulness. The editorial team undertakes to notify a response to the authors within three months from the date of receipt of the article.

Authors are requested to submit articles using the following editorial criteria:

1. To ensure the anonymity of the paper, the names of all authors, full addresses of their institutions and email addresses should not appear in the article, but indicated on a separate file. For the same reason, authors are requested to anonymise their article by avoiding direct references to themselves or their work.
2. Each article should have a length between 8.000 and 12.000 word (including footnotes).
3. Each article must be accompanied by an abstract of no more than 100-150 words summarising the main topics of the article, and three keywords.
4. Footnotes must be entered using the tool of word processing programmes and numbered in Arabic numerals. Book reviews do not have footnotes.
5. Any high-quality images and tables, including notes and captions, must be attached in a separate file, clearly indicating where to insert them.
