## 2. Purpose

The course aims at offering advanced students the necessary tools and methodology to approach the study of religion from a historical-critical perspective, focusing on the African context, and on different religious traditions (Christianity, Islam, African Traditional Religions). Specific relevant subjects and case studies will be analyzed in depth and from a comparative point of view (African-European).

#### 3. Course structure

The specialization course comprises 3 modules, each dealing with an overarching topic. In each module different lecturers will analyze a specific subject/case study, its research methods, the main historiographical perspectives as well as the primary sources. Lecturers will provide reading material and bibliographical suggestions to help students contextualize (and better understand) the analyzed topic. Where possible, lecturers will also present on-line research tools and digital archives resources. A Virtual Exchange Activity guided by trained facilitators from the co-designing institutions will take place in each module and it is an integral part of the seminar. Students will be divided in small transnational groups and will engage in the exercise planned for the session (analysis of a source or reading, debate). They will then exchange the results of their analysis/discussion in the plenary with their colleagues.

#### 4. Expected learning outcomes

- Participants will become familiar with the main methodological steps to study religion from a critical-historical point of view;
- They will thus be able to identify the main tools and resources of academic research, to identify the relevant literature for their research topic, to access and analyze a variety of different sources (both written and oral), and to write their own essays and long papers;
- To strengthen this methodological training, students will also acquire a general knowledge
  of the main historiographical theories and theoretical framework;
- Finally, thanks to the different Virtual Exchanges activities implemented, students will
  enhance their critical thinking, acquire strong intercultural communication skills and
  improve their self-confidence.

**Credits**: Each institution will decide according to its program/syllabus. FSCIRE will give a certificate of attendance to all students attending at least 70% of the program (lectures and VE activities).

**Evaluation**: Each institution will decide according to its program/syllabus.
